March, 2019 New Zealand lost fifty people at Christchurch mosque who were taking prayers on Friday through gun shooting. And lately on Easter Sunday where Sri Lanka has been attacked by total of eight blasts in churches and hotels in Colombo have killed above two hundred and fifty innocent people while hundreds left injured. These are few to discuss as the world has faced lot more of terror attack than these which killed hundreds at once.

#### **Border Disputes**
